## **HELLOWORLD TRAVEL EXPO 2019**

## **Major Attending Prize Draw Terms and Conditions**

- 1. Information on how to enter and prizes form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of Entry by each Entrant.
- 2. The Promotion commences at 10AM (QLD time) on 20/01/19 and closes at 3PM (QLD time) on 23/02/19 (Promotional Period). The Event Draw to determine the winner of the Event Prize will take place at 12PM (QLD time) on 28/02/19 at Helloworld Travel Mackay, 58 Wood Street, Mackay Qld. The winner of the Event Draw will be notified immediately via telephone and email. All reasonable steps to notify the winner will be taken by the Promoter. The Promoter's decision is final and no correspondence will be entered into.
